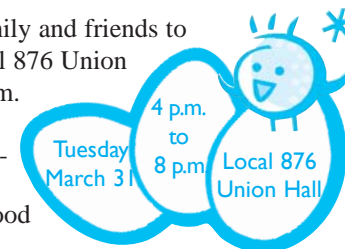
The UFCW awards several scholarships of up to \$8,000 each year. This year's scholarship winners will be notified via mail by Tuesday, June 19, 2009.

## CONTRACT BARGAINING UPDATE

**Polly's Food Service:** Local 876 members working at the Polly's grocery store in Chelsea recently ratified a new, four-year agreement featuring maintenance of health insurance coverage and deductibles, and increases in the employer's contribution to their pension and wage increases.

**Koegel Meats:** Negotiations are scheduled to begin the week of March 23, 2008 between Local 876 and Koegel. The current agreement covering workers at this food processing plant expires April 25, 2009.

**Pat's Food Center:** Preparations for negotiating a new contract are underway for members working at this Freeland grocery store. The current contract expires April 30, 2009.
